INFORMATION and RULES

- ◆ Official set up time begins Saturday 6:30 AM; take down time is Saturday 9:00 PM. Vendor Coordinator will be at the intersection of Camburn & Main for check-in. All vendors have the option to set up and start selling on Friday after 2:00 PM for no additional fee! Check the Friday option on the application below if you plan to set up early, so arrangements can be made for you.
- ◆ Locations for all vendors will be pre-determined by the Stanton Old Fashioned Days vendor committee. Your assigned space for set-up will be designated and numbered.
- ◆ Stanton Old Fashioned Days, Inc. reserves the right to refuse any participant or merchandise.
- ◆ This is a rain or shine outdoor event. No refunds will be given for weather conditions or other unforeseeable circumstances.
- ◆ We do our best to accommodate all requests when possible, but vendors must understand the need for flexibility within the larger scope of festival planning. Arguing, bullying, and/or general disrespect directed toward festival volunteers will not be tolerated. If negative behaviors persist, vendors will be asked to leave the festival without reimbursement of booth fees.

CRAFT & PRODUCT VENDORS

- ◆ Fee is \$50.00 per 10'x10' space. Vendors requiring more space should reserve and make payment for multiple spaces.
- ◆ Only ONE vendor per product brand (i.e. AVON, Thirty-One, etc.) in order of registration. Reserve your spot A.S.A.P!
- ◆ You are responsible for your own tables and chairs. Shade is limited, so come prepared with a canopy, umbrella, etc.

FOOD VENDORS

- ◆ Fee is \$100.00 per food booth up to 30 feet in length. Longer trucks or trailers will require payment for multiple spaces.
- ◆ Must submit a Certificate of Liability from your Insurance Co. with the following listed as additional insureds:

- ◆ Send or attach your FULL food and drink menu. To avoid direct competition, we may request or suggest modifications.
- ◆ Select Food Vendor spaces are available for Sunday events for no additional fee. Check the box to indicate interest.
- ◆ Food booths should provide their own water. Generators are allowed, but must not be loud.
